Section 504 – Rehabilitation Act of 1973 Americans with Disabilities Act of 1990

POLICY STATEMENT

The **County of Richardson, Nebraska,** will ensure that no qualified individual shall, solely on the basis of his or her disability, be excluded from the participation in, be denied the benefits of, or be subjected to discrimination under any of its programs, services, or activities as provided by Section 504 of the Rehabilitation Act of 1973 and the Americans with Disabilities Act of 1990 (ADA). **County of Richardson, Nebraska,** further ensures that every effort will be made to provide nondiscrimination in all of its programs or activities regardless of the funding source.

An individual with a disability is defined by the ADA as a person who:

- Has a physical or mental impairment that substantially limits one or more major life activities,
- · Has a history or record of such an impairment, or
- Is perceived by others as having such an impairment

AUTHORITIES

Section 504 of the Rehabilitation Act of 1973, as amended, provides that "No otherwise qualified individual with a disability in the United States, as defined in section 7(20), shall, solely by reason of her or his disability, be excluded for the participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance.

49 CFR Part 27.13 - Designation of responsible employee and adoption of complaint procedures.

- (a) Designation of responsible employee. Each recipient shall designate at least one person to coordinate their efforts to comply with this part.
- (b) Adoption of complaint procedures. A recipient shall adopt procedures that incorporate appropriate due process standards and provide for the prompt and equitable resolution of complaints alleging any action prohibited by this part and 49 CFR parts 37, 38, and 39. The procedures shall meet the following requirements:
 - (1) The process for filing a complaint, including the name, address, telephone number, and email address of the employee designated under paragraph (a) of this section, must be sufficiently advertised to the public, such as on the recipient's Web site;
 - (2) The procedures must be accessible to and usable by individuals with disabilities.
 - (3) The recipient must promptly communicate its response to the complaint allegations, including its reasons for the response, to the complainant by a means that will result in documentation of the response.

49 CFR Part 28.102 - Enforcement of Nondiscrimination on the Basis of Disability in Programs or Activities Conducted by the Department of Transportation.

This part applies to all programs or activities conducted by the Department except for programs and activities conducted outside the United States that do not involve individuals with disabilities in the United States.

28 CFR Part 35 - Nondiscrimination on the Basis of Disability in State and Local Government Services. The purpose of this part is to implement subtitle A of Title II of the Americans with Disabilities Act of 1990 (ADA Amendments Act) which prohibits discrimination on the basis of disability by public entities.

49 CFR Part 27 - Nondiscrimination on the Basis of Disability in Programs and Activities Receiving Federal Financial Assistance.

The purpose of this part is to carry out the intent of Section 504 of the Rehabilitation Act of 1973 (29 USC 794) as amended, to the end that no otherwise qualified individual with a disability in the United States shall, solely by reason of his or her disability, be excluded from the participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance.

49 CFR Part 28-140 - Employment

- (a) No qualified individual with disabilities shall, on the basis of disability, be subjected to discrimination in employment under any program or activity conducted by the Department.
- (b) The definitions, requirements, and procedures of Section 504 of the Rehabilitation Act of 1973 (29 USC 791), as established by the Equal Employment Opportunity Commission in 29 CFR part 1613, shall apply to employment in federally conducted programs or activities.

29 CFR Part 1614.101 - Federal Sector Equal Employment Opportunity.

It is the policy of the Government of the United States to provide equal opportunity in employment for all persons, to prohibit discrimination in employment because of race, color, religion, sex, national origin, age, disability, or genetic information and to promote the full realization of equal employment opportunity through a continuing affirmative program in each agency.

42 USC Part 12101-12213 - The Americans with Disabilities Act of 1990.

No covered entity shall discriminate against a qualified individual on the basis of disability in regard to job application procedures, the hiring, advancement, or discharge of employees, employee compensation, job training, and other terms, conditions, and privileges of employment.

AMERICANS WITH DISABILITIES ACT (ADA) UPDATE TO SELF EVALUATION OF JANUARY 19, 1993 COURTHOUSE, RICHARDSON COUNTY

This statement will serve as an addendum to the American with Disabilities Act (ADA) Self Evaluation of January 19, 1993 of the County Courthouse of Richardson County, Nebraska, located in Falls City, Nebraska

In 2003, a major addition was added to the north side of the Richardson County Courthouse, a structure that was completed and first occupied in 1924.

This new addition was constructed from an architectural design from the firm of Dennis J. Lyon, Architect of Lincoln, NE. The design was planned to remedy some of the requirements for handicap accessibility to the public facility.

The entrance, which has automated doors, was constructed so that it leads to designated handicap parking which is on the street level, no curbs or steps. After you make entrance to the building from the designated handicap entrance, a wide hallway with handrails leads to the Lower Level offices, an elevator is accessible then to the 1st, 2nd and 3rd floors of the Courthouse.

The 1st Floor of the Courthouse is also the location of the newly constructed handicap restrooms which were installed in 2004.

In the past couple of years, the curbing on the corners around the Courthouse square have been reconstructed to ADA compliance.

As stated in the January 19, 1993, report, the Richardson County Board of Commissioners serve as the ADA Coordinator for the County. They can be reached through the Office of the Richardson County Clerk, Courthouse, 1700 Stone Street, Falls City, NE 68355, telephone 402/245-2911.

Richardson County will continue to use the ADA Grievance Procedure as attached to this report and the report of January 19, 1993.

The Board also reaffirms that the County is making all activities and services in the Courthouse accessible and that the focus of the ADA Act is on making programs, not the buildings accessible. If a service in the building would not be accessible then relocating the service instead of a structural change would be the requirement in meeting it's accessibility. The County is not necessarily required to take steps that would fundamentally alter the nature of a service, or that would impose undue financial hardship or administrative burdens.

- An investigation, as may be appropriate, shall follow a filing of complaint. The investigation shall be conducted by the Richardson County Board of Commissioners. These rules contemplate informal but thorough investigations, affording all interested persons and their representatives, if any, an opportunity to submit evidence relevant to a complaint.

- A written determination as to the validity of the complaint and a description of the resolution, if any, shall be issued by the Richardson County Board of Commissioners and a copy forwarded to the complainant no later than 10 days after its filing.

These rules shall be construed to protect the substantive rights of interested persons to meet appropriate due process standards and to assure that Richardson County complies with the ADA and implementing regulations.
