CALL TO ORDER

The regular meeting of the Richardson County Board of Commissioners was called to order by Chairman Caverzagie at 9:00 a.m. on Wednesday, April 2, 2025. Roll call was answered by Karas, Campbell and Caverzagie. The Invocation was given by Chairman Caverzagie and the Pledge of Allegiance was led by Vice-Chairman Karas. Chairman Caverzagie announced that the open meeting laws have been posted at the entrance to the meeting room.

ROAD & BRIDGE DEPT.

Steve Darveau, Jr., Highway Superintendent updated the Board on the routine maintenance being done on county roads and bridges this past week. It was reported that the deck on the bridge on the road leading into the County yard in Falls City will be poured this week and that this road should be accessible to the County yard in the next few weeks.

LAW ENFORCEMENT CENTER

Sheriff Hardesty updated the Board on the routine business within the law enforcement center the past few weeks. There are 23 inmates currently in the jail with 4 being from other counties.

The Sheriff also reported that Electric Contracting Company is beginning the last phase of the electrical improvement project at the Law Enforcement Center. The Sheriff also informed the Board that during part of this improvement construction project, inmates will need to be housed at other facilities for a short period of time.

The Board also reviewed with Chris Maher of Airstream Heating and Cooling a quote to replace the existing ERV system at the Law Enforcement Center with a AVFO6 Commercial ERV at the price of \$54,026.00. Motion was made by Campbell to approve the quote as presented to replace the existing ERV system at the Law Enforcement Center with a AVFO6 Commercial ERV. Motion seconded by Karas.
