RICHARDSON COUNTY BOARD OF COMMISSIONERS APRIL 16, 2025

CALL TO ORDER

The regular meeting of the Richardson County Board of Commissioners was called to order by Chairman Caverzagie at 9:00 a.m. on Wednesday, April 16, 2025. Roll call was answered by Karas, Campbell and Caverzagie. The Invocation was given by Chairman Caverzagie and the Pledge of Allegiance was led by Vice-Chairman Karas. Chairman Caverzagie announced that the open meeting laws have been posted at the entrance to the meeting room.

Motion was made by Karas to approve the minutes of the April 9, 2025, meeting as read. Motion seconded by Campbell. ROLL CALL VOTE: Karas-aye, Campbell-aye, Caverzagie-aye. Motion carried.

Motion was made by Campbell to add to the agenda an executive session due to an emergency situation at the request from Brian Kirkendall, EMA Director and to approve the remaining agenda as posted. Motion seconded by Karas. ROLL CALL VOTE: Karas-aye, Campbell-aye, Caverzagie-aye. Motion carried. The agenda is posted at the Richardson County Courthouse in the First Floor Lobby, the Lower-Level Lobby and on the Commissioner's Meeting Room door on the 2nd Floor and on the Richardson County website www.richardsoncountyne.gov.

ROAD & BRIDGE DEPT.

Steve Darveau, Jr., Highway Superintendent updated the Board on the routine maintenance being done on county roads and bridges this past week.

The Board reviewed the quotes received through Sourcewell for the purchase of a new wheel loader. Quotes were as follows: NMC, Inc. for \$242,920.00; Titan Machinery for \$248,450.64; A1 Iron Corp. for \$197,302.69; Murphy Tractor for \$210,500.00.

Motion was made by Cambpell to approve the quote from Murphy Tractor & Equipment, Lincoln, NE for \$210,500 which was obtained through Sourcewell contract #011723-JDC. Motion seconded by Caverzagie. ROLL CALL VOTE: Karas-aye, Campbell-aye, Caverzagie-aye. Motion carried.

Motion was made by Campbell to authorize the advertisement to receive sealed bids by Wednesday, April 30, 2025, 9:30 a.m. for the Falls City Southwest pipe replacement project located between Sections 20 and 29, Township 1, Range 16. Motion seconded by Karas. ROLL CALL VOTE: Karas-aye, Campbell-aye, Caverzagie-aye. Motion carried.

Commissioner Campbell presented a statement to the County Board regarding the road department union, a description of the period dating back to early 1990 when the union was enacted at the Road Department and a statement that it is his opinion that it is time to get this matter resolved and make effort to try and settle this matter out of court.

LAW ENFORCEMENT CENTER

Sheriff Hardesty updated the Board on the routine business within the Law Enforcement Center this week. He reported that Electronic Contracting Company is completing the electrical improvement project and plans to have completed on or before May 3. For the past week or so, inmates have been housed in other facilities and plans are to have them all returned by Friday. While this improvement project is being done and the inmates are out of the cell areas, the staff has been doing painting, making repairs and cleaning of the jail facility.

The deputies will be working overtime during the dates of May 12 to June 1 and reimbursed by the grant funds that have been awarded through the Nebraska Department of Transportation for the "Click It or Ticket" grant.

JEREMY INGRAHAM

Jeremy Ingraham of Burlington Junction, MO and an owner of a parcel of real estate at 66318 703 Lane, Rulo, NE, requested to meet with the Board regarding the discovery that he and his wife have made with regards to the FEMA restrictions with no allowance for any new construction to be made on that parcel.
