RICHARDSON COUNTY BOARD OF COMMISSIONERS MAY 13, 2025

CALL TO ORDER

The regular meeting of the Richardson County Board of Commissioners was called to order by Chairman Caverzagie at 9:00 a.m. on Tuesday, May 13, 2025. Roll call was answered by Karas and Caverzagie. Commissioner Campbell was absent. The Invocation was given by Chairman Caverzagie and the Pledge of Allegiance was led by Vice-Chairman Karas. Chairman Caverzagie announced that the open meeting laws have been posted at the entrance to the meeting room.

Motion was made by Caverzagie to approve the minutes of the May 7, 2025, meeting as read. Motion seconded by Karas. ROLL CALL VOTE: Karas-aye, Campbell-absent, Caverzagie-aye. Motion carried.

Motion was made by Caverzagie to approve the minutes of the Board of Equalization meeting from May 7, 2025. Motion seconded by Karas. ROLL CALL VOTE: Karas-aye, Campbell-absent, Caverzagie-aye. Motion carried.

Motion was made by Caverzagie to approve the agenda as posted. Motion seconded by Karas. ROLL CALL VOTE: Karas-aye, Campbell-absent, Caverzagie-aye. Motion carried. LAW ENFORCEMENT CENTER

Deputy Sheriff, Jeremiah Franks updated the Board on the routine business within the Law Enforcement Center this week. He reported that the recently acquired GForce software is being implemented at the Law Enforcement Center.

A quote from IAO Electric, LLC of Hiawatha, KS for the price of \$33,046.00 for labor and materials to connect the East end of the Law Enforcement Center building and the kitchen area to the existing Cummins standby generator on the West end of the building. This price includes adding a transfer switch in the Sallyport electrical Room fed from the current Emergency Transfer Switch in this room. Power will be off in the Kitchen and Sheriff's Office area for up to 2 days. A generator could be set up to run this end of the building while modifications are made, but is not included in this quoted price. The lead time to get a transfer switch is approximately 3 months.

COOPER NUCLEAR STATION

Kimberly Tanner, Emergency Preparedness Offsite Coordinator of the Cooper Nuclear Station at Brownville provided an update to the County Board on the operations of the Cooper Nuclear Station. It was reported that currently the operation is 100% online. The Cooper Nuclear Station is moving away from the outdoor warning sirens to the IPAWS notification system. Dakota Schulenberg was introduced to the Board as he will be taking over as the Emergency Preparedness Offsite Coordinator as Mrs. Tanner announced that she will be retiring at the end of the year. It was also reported that the Cooper Nuclear Station has submitted an application for license extension to move operations through 2054. Thanks and appreciation was also given to the County EMA Director, Brian Kirkendall and his staff for their assistance and work to keep the emergency plans and documents up-to-date. It was also reported that the county agreements will be updated and submitted to the County Board for review later this year.

LUKE BONKIEWICZ, NACO

Luke Bonkiewicz, NACO Research Program Analyst met with the Board to provide information on the programs that NACO is currently working on and the programs available to assist counties with obtaining needed information.

SE NE ADULT DRUG COURT

Chris Reece, PSC Coordinator and Stephanie Corter, Drug Court Secretary presented to the Board the annual report and statistics of the SE NE Adult Drug Court.

Motion was made by Caverzagie to enter into the SE NE Adult Drug Court Interlocal

Agreement for 2025-2026 with Otoe, Richardson, Nemaha, Johnson and Pawnee Counties to provide funding for the continuance of the Adult Drug Court. Motion seconded by Karas. ROLL CALL VOTE: Karas-aye, Campbell-absent, Caverzagie-aye. Motion carried. The funding required from each county: Pawnee-\$1,993.10; Johnson-\$5,965.52; Richardson-\$9,937.93; Nemaha-\$5,965.52; Otoe-\$9,937.93. (Resolution Book 28, Page 46)

Motion was made by Caverzagie to enter into an Interlocal Agreement with the counties of Johnson, Nemaha, Otoe and Pawnee agreeing to Richardson County serving as the fiscal agent and the Nebraska Supreme Court Administrative Office of the Courts and Probation will provide the personnel for the SE NE Adult Drug Court for the period of July 1, 2025, through June 30, 2027. Motion seconded by Karas. Karas-aye, Campbell-absent, Caverzagie-aye. Motion carried. (Resolution Book 28, Page 47)

PENNSYLVANIA COLOLNY HISTORICAL SOCIETY OF NE

Daniel T. Pleiss, Co-President of the Pennsylvania Colony Historical Society of NE and Michelle Heim met with the Board to request funding for the organization pursuant to Nebraska Revised State Statute 23-355.01(2) in which a nonprofit county historical association or society that is not receiving funds from a levy under subsection (1) of this section may request funding from the county.

The Board explained that with the recent legislation in the Nebraska Legislature to decrease and/or eliminate the Inheritance Tax Fund that future funding of the nonprofit historical societies and other organizations will be reviewed further when the County Board sets the budget for fiscal year 2025-2026. The funding for these organizations has been provided for through the Inheritance Tax Fund.
