# RICHARDSON COUNTY BOARD OF COMMISSIONERS JULY 2, 2025

#### **CALL TO ORDER**

The regular meeting of the Richardson County Board of Commissioners was called to order by Chairman Caverzagie at 9:00 a.m. on Tuesday, July 2, 2025. Roll call was answered by Karas, Campbell and Caverzagie. The Invocation was given by Chairman Caverzagie and the Pledge of Allegiance was led by Vice-Chairman Karas. Chairman Caverzagie announced that the open meeting laws have been posted at the entrance to the meeting room.

Motion was made by Karas to approve the minutes from the June 25, 2025, meeting as presented. Motion seconded by Campbell. ROLL CALL VOTE: Karas-aye, Campbell-aye, Caverzagie-aye. Motion carried.

Motion was made by Caverzagie to approve the Board of Equalization minutes from June 25, 2025, meeting as presented. Motion seconded by Karas. ROLL CALL VOTE: Karas-aye, Campbell-aye, Caverzagie-aye. Motion carried.

Motion was made by Karas to approve the agenda as posted. Motion seconded by Campbell. ROLL CALL VOTE: Karas-aye, Campbell-aye, Caverzagie-aye. Motion carried. ### **COUNTY TREASURER**

Rachel Jean, Deputy County Treasurer presented to the Board the request to close out the American Rescue Plan Act Fund (ARPA) special bank account with all remaining interest that has accrued on these funds to be transferred into the County General Fund. The closeout of the Local Assistance Tribal Contingency Fund (LATCF) was also discussed.

Motion was made by Karas to adopt Resolution 2025-2026-1 in reference to closing out the ARPA Fund Account 2580 and the LATCF 2585. Motion seconded by Campbell. ROLL CALL VOTE: Karas-aye, Campbell-aye, Caverzagie-aye. Motion carried.

### ROAD AND BRIDGE DEPARTMENT

Highway Superintendent, Steve Darveau, Jr. updated the Board on the routine maintenance being done on county roads and bridges this past week. An update was given on the current projects being completed and those that will be starting in the next few weeks. Commissioner Campbell reported on a project the Road Department completed in the Preston area and a compliment was received from the landowner on the cooperation that was given by the Highway Superintendent and the Road Department crew.

Mr. Darveau also reported that he has contacted someone from Beatrice who will be servicing the Road Dept. to meet the requirements for CDL instruction and certification.

Gayle Swisegood requested to meet with the Board regarding the County's driveway access policy. The policy that was adopted on June 12, 2018, was reviewed and Mr. Swisegood's questions were answered.

Bill Ely requested to meet with the Board regarding the condition of the county roads past his residence and surrounding area. Mr. Ely indicated that more rock needs to be placed on the county roads and that the budget should allow more funds for rock.

#### **QUARTERLY JAIL INSPECTION**

The Board conducted the quarterly jail inspection and found the facility to be in good order. A leak from the roof was discovered this past weekend after the recent rainfall and a contractor informed the County that the roof had received hail damage that needs to be addressed.
