RICHARDSON COUNTY BOARD OF COMMISSIONERS JULY 16, 2025

CALL TO ORDER

The regular meeting of the Richardson County Board of Commissioners was called to order by Vice-Chairman Karas at 9:00 a.m. on Tuesday, July 16, 2025. Roll call was answered by Karas and Campbell. Commissioner Caverzagie was absent. The Invocation was given and the Pledge of Allegiance was led by Vice-Chairman Karas. Vice-Chairman Karas announced that the open meeting laws have been posted at the entrance to the meeting room.

Motion was made by Campbell to approve the minutes from the July 9, 2025, meeting as presented. Motion seconded by Karas. ROLL CALL VOTE: Karas-aye, Campbell-aye, Caverzagie-absent. Motion carried.

Motion was made by Campbell to approve the Board of Equalization minutes from July 9, 2025, meeting as presented. Motion seconded by Karas. ROLL CALL VOTE: Karas-aye, Campbell-aye, Caverzagie-absent. Motion carried.

ROAD AND BRIDGE DEPARTMENT

Highway Superintendent, Steve Darveau, Jr. updated the Board on the routine maintenance being done on county roads and bridges this past week.

COUNTY TREASURER, AMANDA BARTEK-RAMSEY

County Treasurer, Amanda Bartek-Ramsey presented to the Board the Distress Warrant Collections for 2023 taxes. Two warrants were issued totaling \$180.59 and were collected in full by the Sheriff.

LAW ENFORCEMENT CENTER

Sheriff Hardesty updated the Board on the business within the Law Enforcement Center this past week. It was reported that 16 inmates are currently being held in the jail.

The Sheriff presented to the Board a report that the 2023 tax distress warrants have been collected and the total collected was \$270.71 (warrant total \$180.59 + interest of \$13.92 + service fee of \$36.00 + mileage fee of \$40.20).

Information was also presented to the Board quotes for the purchase of equipment needed for placement in the new patrol vehicles. Discussion was also held regarding the purchase of a 2025 Dodge Charger patrol unit.

Motion was made by Campbell to move forward to purchase a new 2023 Dodge Charger AWD black V6 from ESU Pursuits of Edwardsville, KS for \$37,900. 00. Motion seconded by Karas. ROLL CALL VOTE: Karas-aye, Campbell-aye, Caverzagie-absent. Motion carried.

Motion was made by Campbell to approve a purchase order for the equipment to be placed in the 2023 Dodge Charger from 911 Customs for \$6,120.27. Motion seconded by Karas. Karas-aye, Campbell-aye, Caverzagie-absent. Motion carried.

Motion was made by Campbell to approve a purchase order for the equipment to be installed in one 2025 Ford Police Interceptor from 911 Customs in the amount of \$7,400.00. Motion seconded by Karas. ROLL CALL VOTE: Karas-aye, Campbell-aye, Caverzagie-absent. Motion carried.

TOM BLISS, SE NE DEVELOPMENT DISTRICT

Tom Bliss, Executive Director of the Southeast Nebraska Development District presented to the Board the activity currently being done in Richardson County by SENDD. He also introduced the staff person, Brittany McCullough who has been working with the cities and villages within Richardson County.

Mr. Bliss explained to the Board that grant funding is possible for the purchase of 1st responder radios and possible equipment.

A discussion was also held on updating the Richardson County Comprehensive Plan and proposed zoning regulations. He informed the Board that the University of Nebraska-Lincoln would offer assistance for this project through students who participate in these courses at UNL which could benefit the County with some costs savings. He also explained that there might be some grant funding available to assist with these updates, although this funding has been reduced in the past year.
